## ENMU-Roswell Classrooms to Benefit from Bond C

n this year's November 8 General Election, voters statewide will have the opportunity to invest in the state's public colleges and universities without any increase to their property taxes. General Obligation Bond C (also referred to as Bond C) proposes a total of \$131,106,200 for New Mexico's public colleges and universities, of which \$1 million will be allocated to ENMU-Roswell. These funds will be used to make needed renovations and improvements to outdated classroom facilities. If Bond C passes, Eastern New Mexico University in Portales will receive \$11 million to renovate and upgrade the campus's aging library facility into the Golden Student Success Center. The ENMU-Ruidoso campus would receive \$700,000 for classroom and student services renovations. In total, the ENMU

system would receive \$12,700,000.

Since other bonds are retiring, the net increase in property taxes would be zero. This means NO TAX INCREASE as a result of Bond C. Voter-approved GO Bond funds are the only source of building maintenance funding for ENMU-Roswell. "A yes vote on GO Bond C will ensure that ENMU-Roswell will have the funding available to make needed improvements to some of our older classrooms. Maintaining and upgrading aging facilities allows colleges and universities to educate and train students for highpaying careers and encourages them to stay in our state after graduation, becoming valued members of our workforce," said Eloise Blake, President, ENMU-Roswell Branch Community College Board. "Our project combined with a \$4.8 million renovation of Cahoon Hall

at NMMI will also be a positive stimulus to Chaves County's economy," she said.

Absentee voting begins October 11 and early voting begins October 22. Election Day is Tuesday, November 8, with 15 Voter Convenience Centers in Chaves County open from 7 a.m. to 7 p.m.

### **Bond B To Improve State Libraries**

Voters statewide will also consider Library Bond B on the November 8 ballot. If passed, Bond B will provide \$10,167,000 for all academic, public, school, and tribal libraries in New Mexico. Funds will be used for library materials, equipment, database upgrades and other public resources. As with Bond C, no tax increase is associated with Bond B.

# Aviation Maintenance Program Enrolling New Class for 2017

The Aviation Maintenance Technology program at ENMU-Roswell is now enrolling students for a new class to begin January 9, 2017. Incoming students need to report to the AMT building for orientation on January 4. Students can complete the program in 14.5 months and receive a Certificate of Completion approved by the Federal Aviation Administration. This is one of the fastest Airframe and Powerplant (A and P) certification programs in the country.

# Financial Aid Changes Coming for 2017/18

Students and parents should be aware of several significant changes for the 2017-18 Free Application for Federal Student Aid (FAFSA®) process. Starting with the 2017–18 application cycle, the following changes go into effect:

- Students will be able to submit a FAFSA® earlier. Students will be able to file a 2017–18 FAFSA as early as Oct. 1, 2016, rather than beginning on Jan. 1, 2017. The earlier submission date will be a permanent change, enabling students to complete and submit a FAFSA as early as October 1 every year. (There is NO CHANGE to the 2016–17 schedule. The FAFSA became available January 1 as in previous years.)
- Students will use earlier income information.
  Beginning with the 2017–18 FAFSA, students will be required to report income information from an earlier tax year. For example, on the 2017–18 FAFSA, students (and parents, as appropriate) will report their 2015 income information, rather than their 2016 income information.

These changes benefit students and parents, because the FAFSA will now ask for older income and tax information from tax forms already completed. This will eliminate the need to estimate tax information and returning to the FAFSA later to update it. Because the FAFSA is available earlier, students may also feel less pressure and have more time to

explore and understand their financial aid options and apply for aid before state and school deadlines.

Four Emergency Medical Services students at ENMU-Roswell are on their way to fulfilling their career dreams thanks to the Steve Lovato Memorial Scholarship Fund. The students, Kit Dilley, Courtney King, Shawna Mullins and Stacee Ramirez met with Lovato's parents, Lawrence and Rosie Lovato, on campus recently to express their gratitude. The scholarship will cover the students' educational expenses, including tuition, fees and the purchase of books, as they begin classes this fall semester.

On March 16, 2002, Steve Lovato was killed while on duty working for American Medical Response (AMR) responding to an explosion. Lovato, 30, was an accomplished Emergency Medical Technician-Intermediate and had worked for AMR since 1998. He had planned to continue his education to become a paramedic. Shortly after Lovato's death, the scholarship was created to
