Program Overview

Occupational Therapy Assistants work under the supervision of a Registered Occupational Therapist to help people across the life span participate in the things they want and need to do through the therapeutic use of everyday activities (occupations). The Occupational Therapy Assistant Program (OTA) is a two year program of study. Application to the OTA Program is required. Student enrollment in the OTA core courses is limited. The OTA program curriculum includes three semesters of core coursework followed by 16 weeks Level II Fieldwork. This clinical experience is mandatory and will require out-of-town travel and housing expenses. Through Level II Fieldwork experiences, students will help people with various psychosocial and physical performance challenges. Students will also learn various delivery models reflective of current practice in the profession.

Completion Options

Students can earn an Associate of Applied Science in Occupational Therapy Assistant (A.A.S). Graduates of the program will be able to sit for the national certification examination for the occupational therapy assistant administered by the National Board for Certification in Occupational Therapy (NBCOT).

The A.A.S. in Occupational Therapy Assistant transfers into a Bachelor of Applied Arts and Sciences (B.A.A.S.) degree program at ENMU. Mandatory background checks and drug screenings are required for students enrolled in the program.

1. Assist in an individualized client evaluation, during which the person's goals are determined by the client/family and occupational therapist.
2. Implement therapeutic activities and intervention to improve the person's ability to perform daily activities and reach the goals.
3. Assist in an outcome evaluation/assessment of client progress to ensure that goals are being met and/or make changes to the plan.
4. Collaborate with the OT in implementing evidence-based treatment programs, training patients in therapeutic exercises and activities of daily living, and providing documentation to the OT about the client's responses to and communications during intervention and documentation related to outcome achievement.
