

Important Financial Aid Information for summer 2018

May 15 (subject to change)

Summer financial aid is not guaranteed and is contingent on availability of funds. Completion of the summer request does not guarantee aid eligibility. All students who have a completed 2017-18 FAFSA on file and are enrolled in summer classes will be reviewed for Pell grant eligibility. The summer request forms will be used to review eligibility for student loans and campus-based aid which includes SEOG and State grants and work-study. All campus-based aid is awarded on a first-come, first-serve basis.

- Summer classes begin: June 4
- Last day to add and drop classes: June 5
- Summer Aid & Student Loan request deadline: June 15
- Bookstore charge dates: May 29TH to June 5TH
- First set of financial aid disbursements released: June 18 (loan disbursement dates may be different)

TO BE CONSIDERED FOR SUMMER FINANCIAL AID, THE STUDENT MUST:

- Have a completed 2017-18 Free Application for Federal Student Aid (FAFSA) on file. This means your file must be complete with the Financial Aid Office. (If you received financial aid in the fall 2017 or spring 2018 semester this step should have already been completed.)
- Be degree seeking and enrolled in summer classes that are going toward a degree at ENMU-Roswell. Students must be enrolled in at least 6 credit hours to be considered for SEOG, State grants and student loans and at least 3 credit hours for work-study.
 - Students who received Pell Grant funds during the fall and/or spring and were enrolled full-time may be eligible for additional Pell funds for the summer session (Year-round Pell). In order to be eligible for Yearround Pell, students <u>must be enrolled in at least 6 credit hours</u>.
 - If the summer aid request form is received and you are <u>not enrolled</u> in summer classes, the Financial Aid Office will not process or save the form. A new one will need to be submitted at the time of enrollment.
 - If you are awarded summer work-study and want to continue working after June 30, 2018 you <u>must</u> have a 2018-19 financial aid file completed and work-study awarded before June 15th.
- Be eligible for available campus-based aid, federal grants or student loans.
- Be in compliance with the financial aid satisfactory academic progress policy (SAP). All awards made for summer are contingent on final SAP status after spring grades are posted. <u>http://www.roswell.enmu.edu/student-affairs/financial-aid/satisfactory-academic-progress</u>
- Complete the ENMU-Roswell Summer 2018 Financial Aid Request Form (available starting April 2) • You must be enrolled in summer classes before you submit the form.

IMPORTANT INFORMATION

- Verify your summer hours. Your request will be processed according to the number of credit hours you are enrolled at the time the form is reviewed. Review for increase in credit hours will be made only if funds are available.
- Award notifications and financial aid correspondence will be sent to your ENMU-Roswell student e-mail account, so please check it on a regular basis.
- You are responsible for paying the required deposit as soon as you enroll in order to hold your summer classes or the classes will be dropped, even if you expect to receive financial aid. You will have to re-enroll in classes and the same classes are not guaranteed.
- If you are in a program that will not allow you to pre-register for summer classes until spring grades are posted, you will need to wait to submit the form. We cannot hold funds for cases like this.
- Students must officially withdraw from any classes he/she enrolls in that they do not plan to attend. Students will not be charged for classes dropped during add and drop period.
- Students who received a student loan for the 2017-18 fall and/or spring semesters may not have loan eligibility left for summer session.
- You are required to notify the Financial Aid Office of any other resource or assistance you will be receiving from any outside agencies or donors for the summer session. Ex: WIOA, DVR, Tuition Waiver, Resident Assistant, scholarships, etc.
- Consortium agreement hours from another school will be accepted for Pell grant eligibility only, but will not be accepted for the 6 credit hours required for campus based aid or student loans.
- If the total amount of your anticipated aid does not cover your full tuition and fee balance, you must make arrangements to pay the balance with the Business Office. (575-624-7125)
- If you were enrolled in another school during the 2017-18 school year and will not be degree seeking at ENMU-Roswell for the summer session, you will not be eligible for financial aid.
- Students are required to attend classes in order to be eligible for financial aid. Attendance will be verified before financial aid funds are released. If you do not begin attendance in the classes you enroll in the financial aid awarded will be canceled.
- Double check the major you have declared in the Admissions Office. It could affect your financial aid eligibility if you have not updated your major.
