• Construction Update

- The next construction/design meeting will be held July 11. Estimates for the renovations of the Automotive/Welding building and construction of the Maintenance building are exceeding allocated funds. The architects will work with the construction firm to develop revised plans.

An online student orientation is being developed, and it is scheduled to be in place by the beginning of the fall semester.

Ms. Oldfield will talk to IT about projection screens in the ITC commons area, hopefully to get them installed prior to the August 16 meeting.

College Development has been preparing new program brochures and recruiting materials. They also worked with the City to create a WWII airplane display for the UFO festival, which will provide a photo opportunity for visitors.

Student Affairs instituted a calling campaign to students who have not yet enrolled. A registration blitz will occur August 1. Postcards will be mailed out to announce the event. A date should also be identified in the fall to register students for spring classes. These events need to be widely advertised.

The Business Office is busy closing out the fiscal year. Invoices need to be received by July 15 in order to be paid in the previous fiscal year. If an invoice must be processed after that date, work with Ms. Franklin.
