

#### ENMU-ROSWELL NURSING PROGRAM RANKED NUMBER ONE IN THE STATE

The Eastern New Mexico University-Roswell Associate of Science Nursing Program is ranked number one in the state according to a new list compiled by RegisteredNursing.org. With a score of 95.62, the ENMU-Roswell Associate of Science Nursing Program is the best program on the list of the 2019 Top Ranked Nursing Schools in New Mexico.

"Eastern New Mexico University - Roswell campus is home to an acclaimed associate's degree in nursing (ADN) pathway," the Registered Nursing web site states. "Students complete their first year of requirements, followed by a minimum of 4 semesters of undergrad nursing courses. Ethical, experienced nurse educators form undergraduate nursing philosophy with great care, resulting in strong and responsible graduates who are a credit to their profession."

"We are honored to have received this recognition," said Dr. Laurie Jensen, Vice President of Health Education at ENMU-Roswell. "Our faculty and staff work together to best educate our nursing program learners. Nursing faculty use multiple instructional strategies to develop students' critical thinking skills to incorporate into practice. Our Regional Medical Simulation Center (RMSC) provides nursing students with real-life clinical experiences using high fidelity technology that helps them prepare for practice in the clinical setting. The hard work and dedication of nursing faculty and students is reflected in our successful graduates, many who obtain jobs in Roswell and throughout the State of New Mexico."

"We are honored to have improved our ranking this year," said Rachel Conover, Interim Nursing Director. "It takes a team to achieve such a ranking. This includes students, faculty, staff, other health programs, clinical agencies, and administration. Our goal has always been to produce outstanding nurses to serve our community and state. We are fortunate to have a nursing program at ENNU-Roswell to meet the challenging healthcare needs of our population. In order to meet the needs of our student population, we address all learning styles, and utilize the Regional Medical Simulation Center (RMSC). We promote evidence based practice, clinical reasoning and critical thinking throughout our program. Our graduates exceed expectations and excel in their chosen clinical areas. Employers consistently provide positive feedback regarding our graduates' work ethic and performance," Conover said.

"Selecting the best nursing school in New Mexico can be difficult," the Registered Nursing web site adds. "To make the process easier first look for a school that supports students towards licensure and beyond. A great way to measure this is through NCLEX-RN 'pass rates.' We have ranked the top 10 nursing schools in New Mexico by analyzing current and historical NCLEX-RN 'pass rates,' meaning the percentage of graduates who pass the exam, out of the 21 RN programs in the state." Programs reviewed for the study include schools that offer an Associate in Nursing (ADN/ASN), BSN,

or Direct-Entry MSN Degree.



The Nursing Program at ENMU-Roswell is a two-year course of study, accredited by the Accreditation Commission for Education in Nursing (ACEN). Upon completion of the program, students will earn an Associate of Science (AS) degree, and are prepared to sit for the National Council Licensure Examination for Registered Nurses (NCLEX-RN) exam. #### WHAT'S NEW AT THE LRC

ENMU-Roswell students can find books in our library's collection, in our joint New Mexico Consortium of Academic Libraries (NMCAL) collection and also on WorldCat - the world's largest library catalog - by going to our revised library webpage. They can also access databases from our main Portales campus. To find books and other resources, go to the ENMU-Roswell home page - www.roswell.enmu.edu - and click on "Services" in the upper right hand area of the screen. Then go down the center column on the screen and click on "Library." To find books, click on "Search the Library Catalog." Searches can be conducted, using "Author", "Title" or "Keyword." To access a large variety of databases, click on "Access Online Libraries." If you know the title of a given database you want to access, click on the letter of the alphabet along the top row that corresponds to the first letter of the database title – for example "A" for "Academic Search Premier" or "C" for "CINAHL." If you are accessing the ENMU-Roswell home page and library web page from an off-campus site, you may be asked for a User ID and Password. The User ID is "student" and the password is "roswell1@1." If you need assistance, our regular staff and student employees are available to help. If you are an online student, you can call the Director of the Learning Resource Center at 575-624-7281 or call the main circulation desk at 575-624-7282 for help.

# Try It, Track It Project

PSEUDO-PROJECT BASED- Students are presented with a problem affecting them, the NM Vaping Health Crisis. ~By Lynne Cary

#### **DEFINE THE PROBLEM:**

First year science students struggle grasping chemistry concepts. In fact, chemistry-phobia is as prevalent as math-phobia. Their mind-set is consistent with a self-fulling prophecy, "Chemistry is too hard for me to understand, I can't learn it!" Chemistry is perceived as a formal stuffy discipline. Making it relevant, "jazzing it up" decreases anxiety improving learning outcomes.

### HOW WAS IT ADDRESSED?

My approach starts with 1 selecting a current event that is affecting our student community, 2\_facilitating open-discussion on the event topic, 3 introducing chemistry information in a fun/nonthreatening manner (actually "sneaking" the chemistry in ) and 4 ask students to share interesting links/articles with instructor/classmates. The approach is "pseudoproject based". 1. Students are presented with a problem affecting them. 2. They've "heard" of nicotine, but realize they don't know anything about it! 3.

Now they are motivated learners; asking many questions. i.e. "what is nicotine?, why is it dangerous, addictive or deadly? what does nicotine molecule look like? In a nutshell; a stealth approach/teaching strategy for engaging students in their biochemical world. Students vape they don't want to be sick/die they wonder why its dangerous BINGO - its nicotine, and oh by the way, this is its chemical structure nicotine, and oh by the way, this is its chemical structure.

#### **Key Points:**

Introduce a chemistry topic using a current event. The chemistry topic is nicotine. (most chemistry lectures do not start with a current event)

- Provide the chemistry (molecular structure) of nicotine.
- Provide supporting information on nicotine (its an addictive chemical)
- Engage the students with open discussion, providing opportunity to ask questions on nicotine.

#### WAS IT SUCCESSFUL?

It was a successful project, because students smiled, enjoyed lecture, and

I learned from my students.
A lively, inclusive discussion engaged previously un-engaged students. Students actually thanked me for preparing a PowerPoint lecture for them.

#### **DATA COLLECTED:**

Course is Principles of Biology\_Cell, Molecular\_BIOL 2110 Fall 2019

Several students Bb messaged NM vaping news reports, web-links to American Vaping Association (who knew this existed?!).

Increased out-of class conversation/Bb messages with students on vaping/cigarettes

Mid-term Exam (Bb online, protected in class) Oct. 9 will assess learning outcomes using Bloom's taxonomy recall/remembering\_understanding. Performance will assessed using 75 % as metric standard.

#### WHAT DID YOU LEARN?

Instructor will stay current on local and state events. Pool of student suggestions will focus future lecture topics using project-based and case studies pedagogical methods will improve learning outcomes.
