SECURITY UPDATESafety Tips for the Holiday Season



Will it be real – pine, that wonderful scent, the perfect color? Or fake, long-lasting, pre-lit? Either way, you need to be cautious with your Christmas tree. Electrical fires igniting Christmas trees are a major concern for everyone. It doesn't take much at all to set one off; broken lights, cracked sockets, frayed or bare wires, and loose connections can all cause a major holiday disaster. Always throw out lights that are damaged. Some good tips to follow: For real trees: Make sure the needles are green and do not fall off when touched. This poses a fire, choking, and slipping hazard.

For artificial trees: make sure you have a label, certification, or identification from the manufacturer ensuring that the tree is fire retardant.

For all types of trees, make sure that you keep the tree away from heat sources, which can melt or dry out trees. Avoid sharp decorations and breakable ornaments, which can injure a child or pet. In addition, keep decorations with small, removable parts away from children and avoid using any that resemble candy and could tempt a child to ingest them. ENMU-ROSWELL AMT STUDENTS CELEBRATE GRADUATION

A group of ENMU-Roswell students graduated November 1 from the Aviation Maintenance Technology (AMT) program. The 10 graduates completed the requirements for a Certificate of Achievement in Airframe and/or Powerplant in 14.5 months. The ENMU-Roswell AMT program is a fully approved FAA part 147 maintenance school. Students may complete the Associate of Applied Science degree in 24 months or the certificate program for licensure in 18-months. Students who already hold an Airframe and/or Powerplant license may transfer into the program and receive credit for those credentials.

The AMT program provides students with the necessary skills, knowledge, and attitude required by the Federal Aviation Regulations (FAR). After successful completion of the program, students are prepared to take the federal examinations necessary for obtaining airframe and powerplant mechanics ratings. When ratings have been obtained, students are qualified for employment in the aircraft industry in a variety of positions, including maintenance technician, quality control inspector, and assistant to design, maintenance, and production engineers.

Try It, Track It Project

DELTA BETWEEN ONLINE AND FACE TO FACE ~By Edna Yokum

DEFINE THE PROBLEM:

Upon reviewing the results of the Spring 2019 End of Course Surveys (EOC), it was apparent that changes needed to be made to the curriculum of the online SOC 1110 course. The delta between the online and face to face averages was over 1.5 on top three identifiers.

HOW WAS IT ADDRESSED?

The instructor met with the Area Director of Social and Behavioral Sciences to identify solutions to address the problem. This included a full overhaul of the assignments content, delivery, and formatting.

For example, the Current Event Analysis assignment was revamped. Instead of the students having to find their own articles and answering 12 guestions each week, the assignment was narrowed to instructor-provided content (a mixture of videos and online articles) with streamlined questions (5). Further, there are only 4 Data Workshops, instead of 12, that focus on directed questions for reflection and analysis instead of essay responses to vague prompts.

These two major changes allowed students to engage in the content with more direction from the instructor, which addresses the lack of face to face clarifying instructions and content

explanations. It also removed the sense of "busy work" for the students. Further, it removed excess assignments, and focused instead on delivering assignments that were directly connected to the course learning outcomes.

WAS IT SUCCESSFUL?

Yes. The changes in the EOC data implied that the intervention was successful. Not only did the online EOC data improve to be on par with the face to face sections, but the student's responses were better in the actual assignments with more directions and clarification.

DATA COLLECTED:

I used EOC data for this intervention. First, the EOC results for Spring 2019 made it clear that a change needed to be made. This was evident in the delta between the Instructor At a Glance, as well as the comments by students. After the intervention/changes to curriculum assessment, the instructor looked at the EOC data for Summer 2019 to see if there were any changes. There were. In fact, both the Face to Face AND the online sections EOC data improved from Spring 2019 to Summer 2019. The instructor will review the EOC data for Fall 2019 to verify this finding and to see if any further changes/adjustments could/ should be made.

WHAT DID YOU LEARN?

It is important to respond to student feedback. While EOC data can be problematic, it does provide an important insight into the student experience. Additionally, the revamp process allowed the instructor to clarify course learning outcomes by mapping assignments to the outcomes (content AND skill). This will help the instructor write the General Education reapplication for SOC 1110 for the state as it forced the instructor to rationalize current assignments, while developing new assessment strategies more clearly aligned with the new General Education philosophy on campus.
