- Apply to ENMU-Roswell **(575-624-7141)**
 - Complete FAFSA **(575-624-7400)**
 - Submit ACT Scores, high school transcripts and/or official college transcripts
 - Take the TEAS Test for Allied Health and score a cumulative performance total of at least 58.7% . Make appt at <https://www.roswell.enmu.edu/testing-services/> or call 575-624-7227
 - **Preadmission Requirements** (*must pass with a "C" or better & have minimum 2.75 GPA*):
 - ◇ SOCI 1110: Introduction to Sociology
 - ◇ PSYC 1110: Introduction to Psychology
 - ◇ ENGL: Choose one of the following: ENGL 1110, 1120, or 2210
 - ◇ MATH: Any General Education MATH (MATH 1350 is recommended)
 - ◇ BIOL 2210+L: Anatomy and Physiology I
 - Meet with an academic advisor to go over the degree plan checklist and program requirements, and register for courses **(575-624-7294)**. Schedule an appt: <https://www.roswell.enmu.edu/advising-services/>
 - Discuss payment options with the Cashier's office **(575-624-7125)**
 - Purchase books and supplies **(575-624-7192)**
 - Get your parking permit and student ID at the Security Office **(575-624-7180)**
 - Program is a Fall (August) start program; one cohort a year is accepted
 - The ENMU-R Occupational Therapy Assistant Program is an Associate of Applied Science degree
- The following must be submitted by the application deadline:
- Occupational Therapy Admissions Application on ENMUR OTA Webpage
 - Submit all official transcripts to Admissions and Records
 - Submit Allied Health TEAS Test cumulative score

The associate-degree-level occupational therapy assistant program is on probationary accreditation by the Accreditation Council for Occupational Therapy Education (ACOTE) of the American Occupational Therapy Association (AOTA), located at 6116 Executive Boulevard, Suite 200, North Bethesda, MD 20852-4929. ACOTE's telephone number c/o AOTA is (301) 652-AOTA, and its web address is www.acoteonline.org. Graduates of the program will be eligible to sit for the national certification examination for the occupational therapy assistant administered by the National Board for Certification in Occupational Therapy (NBCOT). After successful completion of this exam, the individual will be a Certified Occupational Therapy Assistant (COTA). Also, all states require licensure to practice; however, state licenses are usually based on the results of the NBCOT Certification Examination. Note: A felony conviction may affect a graduate's ability to sit for the NBCOT certification examination or attain state licensure.
