- I. Leader, Edna Yokum called the meeting to order at 10:05 a.m.
- II. Annemarie May motioned to approve the minutes from July 2, 2020. Destinee Salayandia seconded the motion. Motion carries.
- III. Open Issues: none
- IV. New Issues:
  - a. Action item 1: Community member positions; should a Community College Board (CCB) member be on this committee? Open for discussion.
    - Donna recommended that Tammy Lueras from the CCB be a member. She is the new CCB member and used to be the nursing director on our campus. Griselda Aubert also thought she would be a good candidate.
    - ii. A sports writer from The Roswell Daily Record, J.T. Keith, would like to be part of this committee. Todd agreed that he would be a good candidate to be on the DEI committee.
    - iii. Todd DeKay made a motion that Tammy Lueras and J.T. Keith be on the DEI committee as community members. Annemarie May seconded the motion. Motion carries.
    - iv. Donna will write a letter to both Tammy and J.T. that they have been nominated and approved by the DEI Committee to join. Edna will send J.T.'s email to
  - b. <u>Action Item 2</u>: Creating Ad Hoc Committee to create a form for the nominations to formalize the process of selecting community members for the DEI committee.
    - i. Possible questions on form:
      - 1. Why would you like to be part of the DEI committee?
      - 2. Why should you be chosen by the current DEI committee to be on this committee?
      - 3. What can you bring to the committee?, etc...
    - ii. Annemarie was designated to be the leader on this Ad Hoc committee. Destinee and Griselda agreed to help with the form in a Word document and will forward it to Brianna Bitner so that it can be put into Qualtrics.
    - iii. Todd suggested that it be in electronic form in order to put it in Qualtrics (online survey tool that ENMU-R uses) so that anyone can access it. This will make it easier to provide a link to fill it out and it can be stored for historical purposes.

- iv. Todd made the motion to create the form and committee. Annemarie seconded the motion. Motion carries.
- V. Edna reports back the DEI Committee about the previous weeks' Community College Board meeting
  - a. Edna presented the Charter and Plan to the CCB and they were concerned with some of the grammar on certain items.

Will most likely be done after the campus re-opens for the fall 2020 semester, but before the next CCB meeting.
