- I. Call to Order for Closed Session
 - a. The meeting was called to order at 8:29am.
- II. Changes to agenda
 - a. There were no changes to the agenda.
- III. Electronic Medical Records-no name change
 - a. The Director of Medical Assisting will change the forms to reflect the correct name of the program instead of changing the name of the program.
- IV. Group Two Curriculum Forms
 - a. Media Arts
 - 1. Media Arts-Film Technology AAS
 - a. Change math 1130 to "Any Gen Ed Math: math 1170 recommended" to align with the other tech ed programs on campus.
 - b. All Film programs in the State of New Mexico are implementing the Next Generation Media Academy (NGMA); all colleges across the State of New Mexico to create a degree pathway.
 - c. The description in the catalog does not show they will have to go to Albuquerque. Needs good detail, and that room and board are included in tuition.
 - i. The first semester will be in Roswell (Film Crew I), and the 2nd semester (Film Crew II) will be in Albuquerque with the remaining apprenticeship (FDMA 2165) in Albuquerque, NM.
 - ii. FDMA 2165 Internship is a new 6 credit hour course; the other two courses are already included in the curriculum.
 - d. Financial Aid-cert changing from 16-24 hours which is considered a "significant change" which requires resubmitting to the Department of Education
 - Financial aid will have to submit the change and wait for approval.
 Candace Cantu will need to follow up with Destinee Salayandia in mid to

late spring to make sure this happens with the Portales campus. If all is approved, it will be okay for the fall.

- e. The Albuquerque location needs HLC and HED approval and paperwork will be submitted by Todd DeKay.
 - i. 15 offsite hours and 9 at ENMU-Roswell.
- 2. Media Arts-Graphic Design Technology AAS.
 - a. Change math 1130 to "Any Gen Ed Math: math 1170 recommended" to align with the other tech ed programs on campus.
- 3. Film Technology Certificate of Employment.
 - a. See concerns above regarding location of courses and the requests for HLC and HED.
- 4. FDMA 2120.
- 5. FDMA 2165. FDMA 2165 concerns and requested updates:
 - i. Credit hours calculation concerns-should be 270 for the Math instead of 150
 - 1. FIX: Code the course as a studio course that requires 30 contact hours per credit. This will increase the contact hours to 180, which is within the 20% change allowable by the state.
 - ii. Add "at least 3 references" to CLO #4 in the assessment cell
- 6. FDMA 2125
- b. HVAC-Refrigeration Technology AAS. Change math 1130 to any gen ed with 1170 recommended
- c. Behavioral Sciences-Human Services
 - a. Concerns about all the changes were expressed by the Registrar and so the following recommendations were made:
 - Combining degrees. Behavioral Sciences-Social Work and Behavioral Sciences-Psychology. Mimick Teacher Ed. Create two applications for November 14th meeting. Behavioral Science - Psychology AND Behavioral Science - Social Work.
 - 1. Behavioral Science, AA. see above
 - 2. Deactivate COE Helping Relationship Skills; and CCB and BOR
 - a. No issues. Push this forward.

Deactivating AA – Human Services – CCB and BOR

- b. Table this pending research by Registrar and Director of Financial Aid (like COE Alcohol and Drug abuse Studies below)
- 3. COE: Alcohol and Drug Abuse Studies updating, adding an ethics class, increase from 18-21 credit hours. Will need to be submitted to Destinee Salayandia by midlate spring.
 - a. Table this until research is done by the Registrar and the Director of Financial Aid to see if we can just rename and move it under the newly updated Behavioral Science degree to be the umbrella program; for financial aid reasons.
- 4. HMSV 1020-adding new course Motivational interviewing
 - a. No issues
- 5. HMSV 1150-adding a new course-Intro to Applied Behavioral Management-allows non-traditional students to work while in school

- d. Math
 - a. Mathematics, AS. Need a 2+2. The old math degree was STEM based; only approved halfway and taking more Science than Math. Aligns with ENMU-Portales. Concerns: Under Gen Ed, Math courses can be picked from any. Program requirements show they are required.
 - i. Solutions:
 - 1. Math 1130 and college algebra (1220) Take 1130 before 1220 under Gen Ed. Update application and catalog pages.
 - 2. Coy will resubmit by November 14th.
 - b. Lab science requirement for Gen Ed was changed in catalog, and changes to credit hours were calculated and input.
- e. Arts and Sciences Education
 - 1. Early Childhood Education: Birth-Pre-K. Alternative Licensure, and Certificate of Employability.
 - a. Add alternative licensure under Teacher Ed
 - b. Work with Chris for application and admissions implementation
 - c. After approval from ENMU-Roswell, the program will apply to the State Standards Committee.
 - 2. Early Childhood Education: Pre-K-3rd Grade. Alternative Licensure and Certificate of Employability. For individuals who have a bachelor's degree in any area but teaching. Use this alternative license to teach. See notes above for the other alternative licensure.
 - 3. Deactivating AS Early Childhood Education (non-licensure).
 - a. Low graduation rates for this degree. The difference between non-licensure vs. licensure is the math class. The teachers need a math foundation.
 - 4. Introduction to Early Childhood Education, Certificate of Employability
 - a. Move COE and COT under Teach Ed., keep COT now and evaluate as needed at next year's curriculum session.
 - b. The certificate is aligned with center-based employees and are required to take for ratings at Centers. This cert is specific to courses required.
 - c. Will not be eligible for financial aid.
