3. CE Welding Technology-Adv. Reflects the new course to match the state catalog matrix.
4. AAS Welding Technology. Reflects the new course to match the state catalog matrix.
5. CE Welding Technology-Pipe. Reflects the new course to match the state catalog matrix.
6. CE Welding Technology-Basic. Reflects the new course to match the state catalog matrix.
7. NMYCA Welding. Reflects the new course to match the state catalog matrix.
8. CE__Ag Mech Tech. The wrong course was applied to this certificate. ENGR 222 will replace ENGR 135.
9. COT Heat, Vent & AC Technolgy. Reflects the new course to match the state catalog matrix.
10. AAS Heat, Vent, AC-Ref Tech. Reflects the new course to match the state catalog matrix.
11. AS Mathematics. We are updating this degree to include elective courses to better prepare students for transferring to a four-year institution in engineering and any related STEM field. Students will choose from four electives to meet one course requirement (MATH 1130, MATH 1170, CSCI 1220, or ENGR 1250). Additionally, we are making a change in the required math courses. This is a direct swap: MATH 1230 for MATH 1250. MATH 1250 incorporates the content from MATH 1230 into a new course that will better prepare students for the required Calculus and Physics courses within the program.
