Information Item:

I. CDL Simulator: Community College Board members participated in a variety of driving scenarios ranging from inclement weather to driving around obstacles in the road.

Presidential Remarks:

- I. ENMU President's Remarks: Bond C and Presidential election coming up. Budget cut of five percent during Special Session but still \$100 million short. There is the possibility of more cuts in January and anticipate a 10 percent cut in 2018. This will force institutions to raise tuition and fees, receive community support with Mill Levies and cut expenditures while protecting our staff and students. Portales will cut 2.35 million out of the budget. Confident in all campus staff at our three location.
- II. ENMU-Roswell President's Remarks: Share concerns about budget cuts in 2017 and FY 2018 cuts. Lottery funds might be cut to 60 percent tuition. We cover the difference now but might not be able to cover a 40 percent difference. Bond C for higher education where ENMU-Roswell will receive one million for classroom maintenance, Bond B for libraries and Bond A for senior citizens. New HSI STEM grant will assist in improving teacher education in STEM fields. Thank you to the community for the positive welcome and hospitality of the Tunisians. In negotiation with the Kuwaiti government. Good news about a record breaking number of graduates. Roswell Civic Center (Rubin) has been very accommodating while it is being remodeled. Possible there will be one graduation once the Roswell Civic Center remodel is complete. Article in the Roswell Daily Record about the CDL simulator. Training with the simulator will assist the CDL student to experience different weather driving conditions that they might not experience in our area.
