Presidential Remarks:

I. ENMU – Roswell President's Remarks: Today is the first day of the Legislative session and first day of classes. Enrollment is down about 4% but will be flat when Youth Challenge and the prisons complete the enrollment process. With oil prices down, fall enrollments might be up. The President announced the possibility of free Community College tuition with the Federal Government paying ¾ and states paying ¼. Proposal for State Capital Outlay requests: ADA sign compliance, CDL simulator and vans for the Special Services program. House governed by Republicans for the first time in about 50 years. State will fund the Lottery at 95% and the institution will fund the remaining 5%. Lifetime Achievement Award went to Jane Batson at today's United Way luncheon. Greyhound reception at the Capital tomorrow. Since deciding to tear down the old dorms, three organizations have contacted us about remodeling them. All-state Academic Team will be honored on February 11 at the Capital. SIG will be on campus to assist with Banner. Conference on Autonomous and Unmanned Systems Cluster (A&USC) will be January 30-31.
