



# Financial Aid Consortium Agreement

## Terms and Conditions

This agreement allows financial aid eligible, degree-seeking students to receive federal student aid at ENMU-Roswell for combined enrollment at two institutions. All credit hours at each institution must apply to the student's ENMU-Roswell degree plan.

- Students must be enrolled in at least six credit hours at ENMU-Roswell for fall/spring terms or three hours for the summer term.
- Students must meet all federal student aid eligibility requirements at ENMU-Roswell including satisfactory academic progress.
- Repeated courses must meet aid eligibility requirements to apply to the consortium agreement.
- The number of credit hours at the host institution cannot exceed the number of credit hours at ENMU-Roswell.
- Students must be enrolled in at least 6 credit hours at ENMU Roswell in order to be considered for a student loan.
- Students must meet financial requirements of the host institution, including payment deadlines.
- Complete withdrawal from both ENMU-Roswell and the host institution will result in a return of Title IV funds calculation, and will void the consortium agreement.
- Deadline for completed, signed consortium agreements with required documentation is 6 p.m. on the last day to drop/add for the term.
